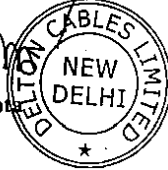

Trump on Tuesday said he detected a shift after Kim and Chinese President Xi Jinping (shee-jih-peeeng) met for a second time in China.

Trump and Kim are scheduled to meet on June 12 in Singapore. Trump now says the meeting could be delayed.

The US and China have been negotiating over China's large trade imbalance with the US.

Kim had South Korean officials inform the White House that he wanted to meet with Trump, but he recently balked in the face of US demands for North Korea's complete denuclearization.

Kathmandu: Two Sherpa guides working on Everest were confirmed dead, bringing the death toll to five.

HAWAII VOLCANO GENERATES TOXIC GAS

Pahoa (US): The eruption of Kilauea volcano in Hawaii sparked new safety warnings about toxic gas on the Big Island's southern coastline after lava began flowing into the ocean and setting off a chemical reaction.

The official media had until recently taken a relatively subdued tone amid the North's diplomatic overtures to its neighbors.

China and the US will exchange views on bilateral relations and issues of common interest, said foreign ministry spokesman Lu Kang, announcing the visit on Tuesday.
